Elementary:

Accreditation and Christian School Associations

Ankeny Christian Academy's elementary school, and grade 6, is accredited by Christian Schools International. The state of Iowa allows schools to be accredited by any of six independent accrediting agencies. Christian Schools International is one of these accepted agencies.

Ankeny Christian Academy's secondary school (grades 7-12) is accredited by the Iowa Department of Education. This is a "Special" or College Preparatory accreditation that requires ACA to maintain a high college acceptance rate.

Ankeny Christian Academy is also a member of the Iowa Association of Christian Schools.
